 - Resolution No. 4/2023 – Granting a discharge to the members of the Executive Committee and the Audit Committee for 2022 financial year;
 - Resolution No. 5/2023 - Approval of the IPMS POLSKA annual work plan for 2023;
10. Any other business;
11. Closure of the General Meeting.
